VSTC 2020 OPENING GUIDELINES & COVID-19 WAIVER

Finally....Happy Summer 😊!!

Based on the size of the main pool , the guidelines given to us by the State of Maryland permit us to have 200 people at the club at one time. Due to this directive we do not feel the need to have a sign up for specific time slots. However, in the unlikely event we are at capacity, we may ask members who arrived early in the day to offer their spot to members that would like to come to the pool. This would be a worst case scenario in order to avoid a sign up program.

-Membership dues are refundable until Monday June 1st. Memberships will be limited and on a space available basis.

BABY POOL

-Per State of Maryland baby pools cannot be open at this time. We will keep you updated should anything change.

SOCIAL DISTANCING

-Valley does have the benefit of a large property that will allow for easy Social Distancing. If Social Distancing is mandated by the local authorities, we will be obligated to monitor compliance. Social Distancing from staff will be expected in either scenario. We hope for everyone's voluntary compliance as we think it will be the essential component of a successful and sustained opening for the summer.

-Pool Deck furniture will be arranged for proper social distancing. We ask that when you are seated at a table ensemble, you be aware of your seating placement and adjust accordingly 6ft away from your neighbors.

-If Social Distance guidelines are in effect at the time of the club opening, children 15 years and younger must be accompanied and supervised by an adult while at the club. It does not have to be a parent, but someone 18 or older.

GUESTS AND BABYSITTERS/CARETAKERS

-Out of an abundance of caution and for the comfort of our members, guests will not be permitted until further notice.

-Our office staff will check members in upon arrival practicing safe social distancing. Only members listed on the membership account will be granted access to the club.

-Babysitter and caregiver names must be registered with the office. There will be no extra charge. All babysitters and caregivers must be 18 or over and will be expected to send in or bring a completed Guidelines & Waiver form (on the website) prior to entry into the club.

SNACK BAR

-To minimize the amount of transactions and personal interaction, we encourage you to pre-purchase coupon books. Please email Mary at valleyswimandtennis@me.com and we will have books in an envelope ready for pick-up at the Pool Admissions Office. We intend to offer this service throughout the summer.

-We encourage you to place prepared food orders (grill food/salads/fried foods, etc.) via text message to (410) 852-5020 when feasible. Menus and ordering instructions are posted on www.valleyswimandtennis.com .

-6 feet markers will be placed in front of the Snack Bar and Bar for quick serve items (drinks/candy/snacks/ice cream etc.) We are still working out the exact ordering procedures for everything at this time – thank you for your patience!

-We are installing a refrigerated touch-less water bottle station. Cups of ice will be for sale at the Snack Bar.

-Snack Bar & food prep employees will follow all COVID-19 guidelines established by the Baltimore County Department of Health.

-Picnic tables under the portico and black café tables are for limited time use. There will be an abundance of open table ensembles and seating around the property.

HEALTH, SAFETY, and SANITATION MEASURES

CDC statement regarding Chlorine:

“There is no evidence that the virus that causes COVID-19 can be spread to people through the water in pools, hot tubs, spas, or water play areas. Proper operation and maintenance (including disinfection with chlorine and bromine) of these facilities should inactivate the virus in the water.”

-Per CDC and WHO guidelines masks are required when entering and exiting the property, using the restrooms, and ordering at the snack Bar. Masks are recommended when not physically in the pool.

-All staff will be temperature checked upon arrival at work.

-Should lifeguards need to administer first aid for any reason they will use a medical grade mask. This is not applicable to CPR.

-Valley will have Hand Sanitizer available.

-Chaise lounges, table ensembles, ladders, railings, and bathrooms will be sanitized daily.

-Members may bring their own Ping Pong paddles and balls, cornhole bags, and basketballs for personal/family use. Valley will not be able to provide these items this Summer. Use of the basketball court will be limited. Gaga Pit will be closed until further notice.

SWIM TEAM

-Unfortunately, the Freestate Swim League has canceled the Summer 2020 swim season.

TENNIS

Families will most likely be able to play tennis together with racquets and balls brought from home. Players must continue to properly social distance from others on the tennis courts. We will continue to monitor our ability to hold lessons, clinics, and camp.

WAIVERS

-Please read, sign and return a copy of the following waiver. All members 18 years and older must have a signed waiver on file at the club for themselves and their children. Please submit them electronically to valleyswimandtennis@me.com.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Valley Swim & Tennis Club ("the Club") has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Club could increase your risk and your child(ren)'s risk of contracting COVID-19.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Club or participation in Club programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program.

I acknowledge and agree that the Club may revise its procedures at any time based on updated recommended guidelines and protocols issued by the Public Health Agencies and further agree to comply with the Club's revised procedures prior to utilizing the facilities.

I further attest that I am not experiencing and symptoms of illness such as a fever, cough, or shortness of breath. If I develop any of these symptoms at a later time, I agree that I will not enter the Club.

I HAVE CAREFULLY READ AND VOLUNTARILY SIGN THIS ASSUMPTION OF RISK AND WAIVER OF LIABILITY. I ALSO UNDERSTAND THAT THIS ASSUMPTION OF RISK AND WAIVER IS MADE ON BEHALF OF MY MINOR CHILD(REN).
